The Special Operations Forces Industry Conference (SOFIC) will be held May 20-23 at the Tampa Convention Center. In conjunction with the industry conference, ARMA Global Corporation will host an event on Tuesday, May 21 at the Tampa Museum of Art to raise awareness and funds for Stay In Step, a local non-profit whose mission is to maintain and grow a Rehabilitation Facility for individuals with spinal cord injuries (SCI).

Chief Warrant Officer (CWO3) Romulo "Romy" Camargo retired from active duty after a distinguished 20 year career. While conducting a combat operation in Afghanistan on September 16, 2008 his Special Forces detachment was viciously ambushed. During the engagement, Romy sustained a gunshot wound to the back of the neck. The gunshot wound paralyzed him from the neck down. Romy's vertebrae was shattered and needed to be extracted. After this surgery, his breathing was tied to a respirator and he was paralyzed from the shoulders down. He was then transferred to James A. Haley VA Hospital in Tampa, Florida where he spent 18 months.

Romulo "Romy" and Gabrielle "Gaby" Camargo are the driving force behind Stay In Step. After having spent nearly two hours each day driving to and from a rehab facility in Orlando, FL, Romy and Gaby decided to create their own facility, a facility for the future. One that has rehab programs and equipment allowing quadriplegics and paraplegics the ability to stand and exercise. With help from events like this, Romy and Gaby opened the Stay In Step Spinal Cord Injury Recovery Center on June 20th 2015 in Tampa, FL. They provide service to veterans and civilians from around the United States.

They achieved their goal of opening a state-of-the-art gym, complete with certified trainers and specialized equipment, but in order to support the growing number of SCI injured veterans in the Tampa area they need your support.

SIS is a unique long-term rehabilitation center that also provides a supportive family environment. The caring staff of SIS have worked tirelessly to create a motivating environment that utilizes advanced therapeutic techniques, modern equipment and "out of the box" thinking to challenge those suffering from a spinal cord injury, traumatic brain injury and/or paralysis to increase their functionality as well as quality of life.
